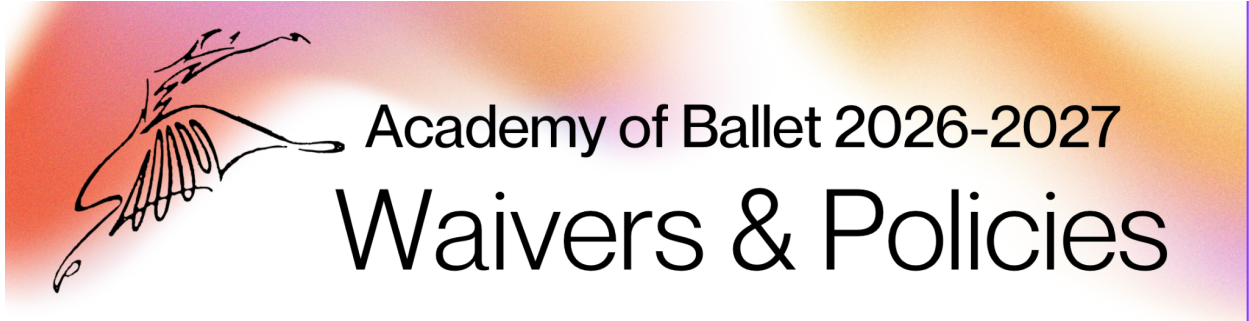




PHOTOGRAPHY RELEASE

WITHDRAWALS

All withdrawals must be completed in writing. Refunds will only be given for remaining classes and are subject to transaction/credit card fees deducted from your payment. Withdrawals after March 31st incur full tuition for April and May. To stop future payments, withdrawals must be submitted in writing 30 days before the next autodraft.

TUITION & REGISTRATION FEES

Tuition is a seasonal/annual fee. This may be paid in full, split into bi-annual payments or split into 10 month installments for your convenience. Late starts are pro-rated. Tuition paid in full up front receives a 10% discount and bi-annual tuition receives a 5% discount. _____ (Initial Here)

Missed classes may be made up, there are no refunds for missed classes. Studio closures for holidays, breaks or inclement weather are not considered missed classes. Ensemble members are required to make up missed classes above 4 absences and/or during Blackout Dates, see Rules & Regulations for full absence policy. ____ (Initial Here)

All registration fees, monthly tuition and costume fees will be on Auto Draft. All other fees, such as workshop fees, audition fees, costume fees etc. will be sent via invoice and must be paid online - not by auto draft. Opting out of Auto Draft will incur a \$5 fee per transaction. _____ (Initial Here)

There is a \$35 fee per NSF, and after two NSF payments a \$60 fee. Future payments after two NSF payments must be made in cash by appointment only. _____ (Initial Here)

Payments made after the 15th will incur a \$15 late fee.

SPRING RECITAL

The spring recital will take place between March and May of 2027. Academy Performing Ensemble members are required to attend classes through the end of May (with tuition paid through April & May) to participate in recital. Accounts must be current to participate in recital and accounts with large outstanding balances will not be permitted to perform.

Participation in the spring recital is mandatory for members of the Academy Performing Ensemble _____ (Initial Here)

There is a \$190 recital fee per dancer or \$319 recital fee per family split into installments included with monthly tuition. This fee covers production costs including venue rental, payroll, backdrops, props & other expenses. This fee includes 4 tickets per dancer or 6 tickets per family to be

split among shows however desired (not per show).

COSTUME FEES

Costume fees are typically \$120 per performing class. When possible, certain classes like tap or hip hop may use street clothes to eliminate this fee. Costume fees are not included in monthly auto drafts and must be paid manually. Costume fees are due by November 15th.

By registering with Academy of Ballet, I agree to all of the above listed conditions.
